June 29th – July 3rd, 2020

Registration is at 9:00 AM at the Lodge Monday, June 29th. PLEASE DO NOT ARRIVE EARLY. We understand that some families have travel plans for Friday and won't be able to attend, but we will be operating that day! **Campers should be picked up at 4:00 PM every afternoon except Friday, July 3rd.** We invite parents to join us for the **Day Camp closing program at 3:15 PM on Friday.** Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.

Payment Information

Balance of the camp registration fee is due no later than **June 22nd**. (Arrangements can be made in advance with the office to automatically charge a VISA/MasterCard for the remaining balance.) The deposit of \$40 is non-refundable upon cancellation of your camp reservation.

Camper E-mail:

Medications

Prescription medication must be in its original container with an accurate pharmacy label indicating camper's name, medical provider, dose and timing. Be sure to bring any inhalers or epi pens needed for your camper.

Camp Store

Our store will be open during free-time each afternoon! This year we are including a T-Shirt with the price of your registration! We will also be providing two snacks per day in our camp store, there is no need to send money each day with your camper. The store will be open on Friday after the closing program for items you may wish to purchase at the end of the week. There is no charge for crafts during the week!

Visitors

We welcome visitors to tour camp upon check-in and on closing day of each camp. If you must see your child, make prior arrangements with EFC's Program Director, and your child's weekly director. This is important for the flow of the week and for the protection of campers.

Care Packages

We request that you please do not mail large "care packages" of candies and goodies to camp. Thank you.

Telephone Calls

Please limit calls to emergencies only. If an emergency requires you to contact your camper, call the camp office at **503-630-4978**. Office hours are 8 AM – 5 PM Monday – Friday. You may also contact the weekly director at **503-630-5924** during non-business hours. Campers are allowed to make outbound calls only in an emergency.

Lice and Nits Policy and Procedures

Upon registration check-in or at the bust stop on the first day, every camper must report for a mandatory head check. Do not come to registration on Monday morning with cornrows, braids or wet hair. Please check your child for lice and/or nits a few days prior to camp, any camper found with lice and/or nits will not be registered for camp and will be sent home immediately.

Food Allergy Disclaimer

Parents concerned about food allergies may want to send a lunch from home with their camper. Eagle Fern Camp makes every attempt to identify ingredients that may cause allergic reactions for those with food allergies. Every effort is made to instruct our food production staff on the severity of food allergies. However, there is always a risk of contamination. There is also a possibility that manufacturers of the commercial foods we use could change the formulation at any time, without notice. Those who are concerned with food allergies need to be aware of this risk. Bus Information

Your child should be at the bus pick up location 15 minutes prior to scheduled departure. (see below for locations and corresponding times) You must choose one location only for your child to be picked up/dropped off the entire week. No location switching will be allowed. **Day Camp is from 9:30 to 4:00 Monday-Friday.** We invite parents to join us for the Day Camp closing program 3:15 PM on Friday. Please note there will be no afternoon bus service provided for Day Camp on Friday. Names of those authorized to pick up campers need to be on file at the office. **Photo I.D. is required to pick up your child at camp or the bus location.**
