## Arrival and Departure Information

Registration is from 6:00-7:00 PM on Sunday, July 7<sup>th</sup>. **PLEASE DO NOT ARRIVE EARLY.** Campers should be picked up at 6:00 PM on Friday, July 12<sup>th</sup>. **Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.**

## Opening Night

We will be providing a generous snack after the opening program for our campers! The program will begin at 6:30 PM and will be a great transitional time for your camper. The main program will begin at 7:15 PM after the registration process is complete.

## Payment Information

Balance of the camp registration fee is due no later than [June 28<sup>th</sup>](#). (Arrangements can be made in advance with the office to automatically charge a VISA/MasterCard for the remaining balance.) The \$50 deposit is non-refundable upon cancellation of your camp reservation.

Prescription medication must be in its original container with an accurate pharmacy label indicating camper's name, medical provider, dose and timing. Be sure to bring any inhalers or epi pens needed for your camper.

**Lice and Nits Policy and Procedures**

Upon registration check-in every camper must report for a mandatory head check. Do not come to registration on Sunday evening with cornrows, braids or wet hair. Please check your child for lice and/or nits a few days prior to camp, any camper found with lice and/or nits will not be registered for camp and will be sent home immediately.

**Visitors**

Due to safety precautions this summer, we will not be allowing visitors to tour camp during the week of camp or at opening/closing. If an emergency arises that requires you to see your camper, please call ahead to speak with EFC's Program Director and/or your child's weekly director and we will do our best to accommodate.
