## Arrival and Departure Information

Registration is from 6:00-7:00 PM on Sunday, July 28<sup>th</sup>. **PLEASE DO NOT ARRIVE EARLY.** Campers should be picked up at 9:00am on Saturday, August 3<sup>rd</sup>. **Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.**

## Opening Night

The program will begin at 6:30 pm in the main lodge and will be a great transitional time for your camper. We will be providing a generous snack. The main program will begin at 7:15 pm after the registration process is complete.

## Payment Information

Balance of the camp registration fee is due no later than July 19<sup>th</sup>. (Arrangements can be made in advance with the office to automatically charge a VISA/MasterCard for the remaining balance.) The \$50 deposit is non-refundable upon cancellation of your camp reservation.
