## Arrival and Departure Information

Registration is from 6:00-7:00 PM on Sunday, July 20<sup>th</sup>. **PLEASE DO NOT ARRIVE EARLY.** Campers should be picked up at 6:30 PM on Friday, July 25<sup>th</sup> (\*TCL Staff see bottom of page 2). **Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.**

## Opening Night

The main program will begin at 7:15PM after the registration process is complete. We will not be serving a meal on opening night, so be sure that your child eats dinner before coming to registration on Sunday night.

## Payment Information

Balance of the camp registration fee is due no later than July 10<sup>th</sup>. (Arrangements can be made in advance with the office to automatically charge a VISA/MasterCard for the remaining balance.) The \$50 deposit is non-refundable upon cancellation of your camp reservation.

## What to Bring to Camp

- Bible, notebook, and pencil/pen
- Flashlight
- Modest swimsuit, sunscreen
- Active wear for a week
- Soap, towels, washcloth, toiletries
- Clothes for evening activities
- Spending money for camp store and crafts
- Athletic shoes (2 pairs)
- Water shoes/sandals
- Warm coat
- Sleeping bag & pillow

\*\*\*Modest clothing is required at all times. Two-piece swimsuits need to be covered by a tank top or shirt. Male campers must wear shirts at all times unless at the waterfront. All shorts must be of a modest length, ensuring appropriate bodily coverage. Shirts must cover the entire midriff when walking. Crop tops are not permitted. Weekly Directors have discretion to ask campers to change into more appropriate clothing.

Please label all belongings (EFC will not be responsible for lost items). **DO NOT BRING** valuables like cell phones (These must remain locked in your car if brought with you to camp). In addition, do not bring weapons, fireworks, drugs, alcohol, tobacco, questionable printed material or videos, or anything with nuts in it.

## Medications

Prescription medication must be in its original container with an accurate pharmacy label indicating camper's name, medical provider, dose and timing. Be sure to bring any inhalers or epi pens needed for your camper.

## Camp Store

We include a free T-Shirt with the price of your registration! In addition, the store sells stuffed animals, Bibles, snacks, etc. If you didn't add money for the store during online registration, you can log into our online system or call the office (503-630-4978) to let us know how much you'd like to add. Eagle Fern Camp will not be responsible for any lost or stolen money that is sent directly with a camper.

## **Lice and Nits Policy and Procedures**

Upon registration check-in every camper must report for a mandatory head check. Do not come to registration on Sunday evening with cornrows, braids or wet hair. Please check your child for lice and/or nits a few days prior to camp, any camper found with lice and/or nits will not be registered for camp and will be sent home immediately.

## **Visitors**

Due to safety precautions this summer, we will not be allowing visitors to tour camp during the week of camp or at opening/closing. If an emergency arises that requires you to see your camper, please call ahead to speak with EFC's Program Director and/or your child's weekly director and we will do our best to accommodate.

## **Telephone Calls**

Please limit calls to emergencies only. If an emergency requires you to contact your camper, call the camp office at 503-630-4978. Office hours are 8 AM – 5 PM Monday – Friday. You may also contact the weekly director at 503-630-5924 during non-business hours. Campers will be allowed to make outbound calls only in an emergency.
