### Arrival and Departure Information

Drop-Off is between 5-5:30 pm at the lodge on Sunday, March 23<sup>rd</sup>. **PLEASE DO NOT ARRIVE EARLY.** Campers should be picked up at 11:00 am in the plaza on Wednesday, March 26<sup>th</sup>. **Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.**
