Arrival and Departure Information

Drop-Off is between 5-5:30 pm at the lodge on Sunday, March 22nd. **PLEASE DO NOT ARRIVE EARLY.** Campers should be picked up at 11:00 am in the plaza on Wednesday, March 25th. **Names of those authorized to pick up campers need to be on file at the office. Photo ID is required to pick up your camper.**

What to Bring to Camp

Please label all belongings (EFC will not be responsible for lost items). **DO NOT BRING** valuables like cell phones, iPods/MP3 players or radios. In addition, do not bring glass water bottles, weapons, fireworks, drugs, alcohol, tobacco, questionable printed material or videos, or anything with nuts in it. All such banned personal electronic devices will be collected at the beginning of the week and locked in the camp office for until pick up day.
